**Categories of Records to Be Delivered Electronically**

I understand that you will use an electronic record to provide or make available the following categories of information relating to transactions between you and me.

- Your Statement of Terms, Conditions and Disclosures for MariSol Federal Credit Union membership, accounts and services, including notices and disclosures required under the federal Truth in Savings Act and Electronic Funds Transfer Act.
- Periodic statements for checking, savings and loan accounts, including notices and disclosures required under federal law.
- Rate Sheets, including notices and disclosures required under federal law.

**Right to Paper Record**

**Right to Withdraw Consent**

I may withdraw my consent and terminate this Agreement at any time by notifying you in writing at the address above, or by electronic means through Flex Teller. I agree to allow you a reasonable time to resume providing disclosures and other information covered by this Agreement in written form. There are currently no conditions, fees or other restrictions relating to my withdrawal of consent. However, you reserve the right to impose such conditions, fees or other restriction at any time upon such conditions, fees or other restrictions at any time upon such notice as may be required by law.

**Updated Contact Information**

If I change my e-mail address, Internet Service Provider or other information needed to contact me electronically, I must provide you with updated information by written notice sent to the address above or by electronic notice through Flex Teller. **If my email address is no longer valid and statements cannot be delivered, MariSol may elect to stop electronic delivery and return to normal postage delivery at their option without notice.**

**Hardware and Software Requirements**

I understand that I must maintain a system with a web browser (Microsoft Internet Explorer, version 6, and Adobe, version 7) in order to receive disclosures electronically. Further, I must have a printer capable of printing any disclosures or account statements that are e-mailed to me and/or made available on you website, or have the ability to electronically save and visually display on my computer screen such documents.
