**Categories of Records to Be Delivered Electronically**

I understand that you will use an electronic record to provide or make available the following categories of information relating to transactions between you and me.

- Your Statement of Terms, Conditions and Disclosures for MariSol Federal Credit Union membership, accounts and services, including notices and disclosures required under the federal Truth in Savings Act and Electronic Funds Transfer Act.
- Periodic statements for checking, savings and loan accounts, including notices and disclosures required under federal law.
- Rate Sheets, including notices and disclosures required under federal law.

**Right to Paper Record**

I may obtain a paper copy of any disclosure or other information received electronically under this Consent by mailing a written request to the address below:

Or I may also request a paper copy electronically through Flex Teller your home banking service. I must identify the specific record requested. Or I may come to any branch of MariSol Federal Credit Union and request a paper copy in person.

**Right to Withdraw Consent**

Consent remains valid until you withdraw consent. I may withdraw my consent and terminate this Agreement at any time by notifying you in writing at the address above, or by electronic means through Flex Teller (MariSol online banking). I agree to allow you a reasonable time to resume providing disclosures and other information covered by this Agreement in written form.

**Statement are available for 24 months after issuance.**

**Updated Contact Information**

If I change my e-mail address, Internet Service Provider or other information needed to contact me electronically, I must provide you with updated information by written notice sent to the address above or by electronic notice through Flex Teller. **If my email address is no longer valid and statements cannot be delivered, MariSol may elect to stop electronic delivery and return to normal postage delivery at their option without notice. MariSol charges a monthly fee for mailed paper statements.**

**Hardware and Software Requirements**

I understand that I must maintain a system with a web browser in order to receive disclosures electronically. Web Browser requirements change frequently, go online to [www.marisolcu.org](http://www.marisolcu.org) to get current web browser requirements or call 602-252-6831. Further, I must have a printer capable of printing any disclosures or account statements that are e-mailed to me and/or made available on your website, or have the ability to electronically save and visually display on my computer screen such documents.
